BYLAW 22-043 OF LAC LA BICHE COUNTY

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF MAKING AMENDMENTS TO THE SCHEDULE OF FEES BYLAW 20-002.

WHEREAS under the authority and pursuant to the *Municipal Government Act*, RSA 2000, Chapter M -26 Sections 7 Lac La Biche County may pass bylaws for municipal purposes respecting people, activities and things in, on or near a public place or place that is open to the public;

AND WHEREAS Section 7 of the Act provides that a municipality may pass bylaws for services provided by or on behalf of the municipality;

AND WHEREAS Section 8 of the Act provides that a municipality may pass a bylaw to establish fees for licenses, permits and approvals;

AND WHEREAS Lac La Biche County has established a schedule of fees bylaw for various municipal services and it is now deemed appropriate to amend the schedule of fees bylaw;

NOW THEREFORE under the authority and subject to the provisions of the *Municipal Government Act*, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

Bylaw 20-002 Amendments:

- 1. That Bylaw 20-002, being the Schedule of Fees Bylaw, is amended as follows:
 - (a) That Schedule A Administrative Fees table of the Schedule of Fees Bylaw shall be amended by substituting the following fees:

(i)	NSF Cheques	\$ 25.00
(ii)	Tax Certificates & Searches	\$ 35.00
(iii)	Registering Tax Notifications	\$100.00

- (b) That Schedule A Administrative Fees table of the Schedule of Fees Bylaw shall be amended by adding the following item and fee:
 - (i) Accounts Payable Fees Lost cheque/cheque cancelling Fee \$ 25.00
- (c) That Schedule F of the Schedule of Fees Bylaw shall be renamed from "Fire Services" to "Protective Services" throughout the text of the Bylaw.

(d) That Schedule G – Infrastructure & Transportation table of the Schedule of Fees Bylaw shall be amended by substituting the following fees:

(i)	Grader Flags	\$50.00
(ii)	Snowplow Flags	\$50.00

(e) That Schedule G – Infrastructure & Transportation table of the Schedule of Fees Bylaw shall be amended by adding the following items and fees:

(i)	Gravel Approach	\$3,900
(ii)	Asphalt Approach	\$10,600

- (f) That Schedule H Legislative Services table of the Schedule of Fees Bylaw shall be amended by substituting the following fees:
 - (i) Assessment Review Board (ARB) Appeals

٠	Residential/Farmla	and (per parcel)	\$ 50.00	
٠	Non-Residential	(per parcel)	\$250.00)

- (g) That Schedule J Utility Fees table of the Schedule of Fees Bylaw shall be amended by substituting the following fee:
 - (i) Septage Hauling Deposit \$100.00
- (h) That Schedule J Utility Fees table of the Schedule of Fees Bylaw shall be amended by adding the following item and fees:

(i) Hydrovac Dumping Fees

•	Single Axel	\$100.00
•	Tandem Axel	\$150.00
•	Triple Axel	\$200.00

- (j) That Schedule K Waste & Recycling Management table of the Schedule of Fees Bylaw shall be amended by adding the following note under Section 1:
 - (i) NOTE: C & D rates are prorated for loads under 1 tonne for Residential only.

Severability

2. Each provision of this Bylaw is independent of all other provisions. If any such provision is declared invalid by a court of competent jurisdiction, all other provisions of this Bylaw will remain valid and enforceable.

Effective Date

3. This Bylaw shall come into force and effect January 1, 2023
