

**BYLAW 08-033  
OF  
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF PROVIDING FOR THE IMPOSITION OF PENALTIES ON UNPAID PROPERTY TAXES.

---

WHEREAS under the authority and pursuant to the Municipal Government Act, Chapter M 26, R.S.A. 2000, Sections 344, 345 and 346, and amendments thereto, Council may impose penalties on unpaid taxes;

AND WHEREAS the Council of Lac La Biche County deems it expedient to impose penalties on unpaid taxes;

NOW THEREFORE under the authority and pursuant to the provisions of the said Municipal Act, and by virtue of all other enabling powers, the Council of Lac La Biche County, duly assembled, enacts as follows:


1. That all property taxes of Lac La Biche County shall be due and payable in full on or before the 30<sup>th</sup> of June each year.
2. A penalty rate of five percent (5%) shall be imposed on July 1<sup>st</sup> in each year, on property taxes remaining unpaid after June 30<sup>th</sup> in the current year and on any property taxes remaining unpaid from previous years.
3. Should the day June 30<sup>th</sup> in any year be a weekend or statutory holiday, the tax payable date shall be the next business day with the penalty imposed the day following.
4. A second penalty of seven percent (7%) shall be imposed on November 16<sup>th</sup>.
5. Should the day November 15<sup>th</sup> in any year be a weekend or statutory holiday, the tax payable date shall be the next business day with the penalty imposed the day following.
6. This Bylaw rescinds Bylaw 05-019 of the former Lakeland County, imposing penalties on unpaid property taxes and this Bylaw also rescinds Bylaw 1222/05 of the former Town of Lac La Biche establishing penalties for non-payment of taxes and tax arrears.
7. This bylaw shall come into effect upon passing of the third reading.
